

Thank You For Participating in the Town of Oxford Community Electricity Aggregation (CEA) Program!



Oxford CEA is the Town of Oxford's program to provide competitively priced, stable electricity rates to our residents and businesses. The program started in July 2017, and we thank you for your participation. With Oxford CEA, National Grid continues to deliver the electricity, maintain the poles and wires, and manage all electricity billing. The only change is the source and cost of electricity supply, chosen through a competitive bidding process by the Town of Oxford.

Oxford CEA is **changing electricity suppliers from Public Power to NextEra Energy Services** starting January 2020. You will see a notice in your February 2020 National Grid electricity bill. **You do not need to take any action** to remain in the Oxford CEA program.

26% Our new rate, starting in January 2020, is **26% lower than National Grid's current Basic Service Supply** rate for residential customers. National Grid's rate is fixed from November 2019 through April 2020. Future savings cannot be guaranteed.

In 2020, Oxford CEA will offer a new, clean electricity rate as an option for residents and businesses: 100% additional local renewable energy exclusively sourced from New England.

New Electricity Rates & Options

The following rates and costs apply from January 2020 through December 2022 (35 months).

Standard Product

Oxford residents and businesses in the program receive the standard product unless one affirmatively selects the Premium 100% Local Green option. The standard product will be **10.316 cents per kWh**, which is a **decrease** from the current 10.430 cents per kWh.

Premium 100% Local Green


Oxford CEA is offering an option for residents and businesses that want to help fight climate change and use clean energy. This option goes above and beyond state requirements by sourcing an additional 100% of your electricity from New England-based renewable energy, classified as MA Class I. Your renewable energy will come only from solar, wind, small hydroelectric and anaerobic digestion facilities located in New England and built after 1997. The rate for Premium 100% Local Green will be **12.366 cents per kWh**.

Opting up to Oxford Premium 100% Local Green will typically cost the average Oxford household \$15 per month compared to the standard product.

Delivering Value to Oxford

The cost of Oxford CEA has been lower than National Grid's Basic Service for residential customers since the program launched in July 2017. **That's over two and a half years of lower costs for Oxford's residents.**
